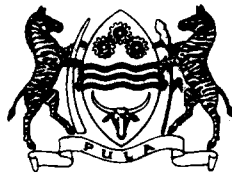


THE APPROPRIATION (1970/71) ACT, 1970

AN ACT TO AUTHORISE THE PAYMENT OUT OF THE CONSOLIDATED FUND AND THE DEVELOPMENT FUND OF SUMS OF MONEY FOR THE YEAR ENDING ON THE 31st MARCH, 1971.

Date of Assent: 31.3.70

Date of Commencement: 31.3.70

ENACTED by the Parliament of Botswana.

Short Title

1. This Act may be cited as the Appropriation (1970/71) Act, 1970.

Expenditure from Consolidated Fund

2. The Minister of Finance may issue a warrant for the payment from the Consolidated Fund for the year ending on the 31st March, 1971, of the sum of R13,295,219 (thirteen million two hundred and ninety five thousand two hundred and nineteen rand).

Appropriation

3. The sum authorised by section 2 is appropriated to and shall be applied for the purposes of the heads of expenditure set out in the first and second columns of the First Schedule, in the amounts set opposite thereto in the third column of that Schedule.

Expenditure from Development Fund

4. The Minister of Finance may issue a warrant for the payment from the Development Fund for the year ending on the 31st March, 1971, of the sum of R16,637,813 (sixteen million six hundred and thirty seven thousand eight hundred and thirteen rand).

Appropriation

5. The sum authorised by section 4 is appropriated to and shall be applied for the purposes of the heads of expenditure set out in the first and second columns of the Second Schedule, in the amounts set opposite thereto in the third column of that Schedule.
