AN ACT TO AMEND THE TATI CONCESSIONS LAND PROCLAMATION AND TO MAKE CERTAIN CONSEQUENTIAL AMENDMENTS TO THE TRIBAL LAND ACT, 1968.

Date of Assent: 25.11.70.

Date of Commencement: 14.12.1970

ENACTED by the Parliament of Botswana.

Short Title

1. This Act may be cited as the Tati Concessions Land (Amendment) Act, 1970.

Amendment of section 2 of Cap. 112

2. Section 2 of the Tati Concessions Land Proclamation (hereinafter called the principal law) is amended —

- (i) by the repeal of subsections (2), (3) and (4); and
- (ii) by the renumbering of subsection (1) as section 2.

Amendment of section 3 of the principal law

3. Section 3 of the principal law is amended by the deletion of the word “Third” appearing therein.

Repeal of section 4 of the principal law

4. Section 4 of the principal law is repealed.

Amendment of section 5 of the principal law

5. Section 5 of the principal law is amended by the deletion of the words “for Africans or for the Rhodesia Railways, Limited, or land selected as sites by the President as hereinbefore set forth” and the substitution therefor of the words “for the Rhodesia Railways, Limited”.

Repeal of Schedules 1 and 2 to the principal law

6. The principal law is amended by the repeal of Schedule 1 and Schedule 2 thereto.

Amendment of remaining Schedule to the principal law

7. Schedule 3 to the principal law is amended as follows —

- (i) by the deletion of the figure “3” appearing after the word “SCHEDULE”; and
- (ii) by the deletion of the word “THIRD” in the heading thereof.

Amendment of Act 54 of 1968

8. The Tribal Land Act, 1968 is amended by —

- (i) in the Arrangement of Sections, the deletion of the word “SCHEDULE” and the substitution therefor of the words —

“FIRST SCHEDULE

SECOND SCHEDULE”;

- (ii) the deletion of the word “Schedule” wheresoever that word occurs and the substitution therefor of the words “First Schedule”; and

- (iii) the addition, immediately after the First Schedule, of the following Schedule —

“SECOND SCHEDULE

A straight line drawn from beacon No. 12 (58) on the Southern Rhodesia border due south to a point where such straight line strikes the Inchwe River; thence along the Inchwe River to a point where the Inchwe River is intersected by a straight line drawn from Ramokgwebane Railway Siding to the south side of Pole's Kraal; thence by a straight line from the Inchwe River to Pole's Kraal; thence by a straight line to the south side of Masunga's Kraal; thence from Masunga's Kraal by a straight line crossing the Vukwe River to Dombashaba Mountain; thence by a straight line from Dombashaba Mountain to Needle Rock; thence by a straight line from Needle Rock to the northern extremity of the Vukwe Mountains; then along the watershed of those mountains until the Vukwe River is reached one and a half miles below the Vukwe Drift; thence from the before-named junction of the mountains with the Vukwe River along the Vukwe River to its junction with the Shashe River; thence in a northerly direction following the boundary of the Tati District from the lastnamed junction along the Shashe River to its source, which is marked by beacon No. 1; thence in a south-easterly direction along the watershed which constitutes the northern or north-eastern boundary of the Tati District, and which watershed has been scientifically surveyed and remains defined by beacons until beacon No. 12 (58) beforenamed is reached”.

Amendment of section 2 of Act 54 of 1968

9. Section 2 of the Tribal Land Act, 1968 is amended by the deletion of the definition “tribal area” appearing therein and the substitution therefor of a new definition as follows —

““tribal area” means —

- (a) every tribal territory as defined in section 2 of the Chieftainship Law, 1965 (29 of 1965); and
- (b) the area defined in the Second Schedule hereto;”.

Amendment of section 10 of Act 54 of 1968

10. Section 10 of the Tribal Land Act, 1968 is amended by —

- (i) the repeal of subsection (2); and
- (ii) the renumbering of subsection (3) as subsection (2).

Amendment of First Schedule to Act 54 of 1968

11. The First Schedule of the Tribal Land Act, 1968 is amended —

- (i) in the first column thereof, by the deletion of the words —

"The area defined in Schedule 1 of the Tati Concessions Land Proclamation (Cap. 112)"

and the substitution therefor of the words —

"The area defined in the Second Schedule to this Act"; and

- (ii) in the third column thereof, in subparagraph (b) (i) of the paragraph appearing opposite the hereinbefore amended words in the first column, by the deletion of the words —

"Schedule 1 of the Tati Concessions Land Proclamation"

and the substitution therefor of the words —

"the Second Schedule to this Act".
