THE CENSUS PROCLAMATION (CHAPTER 45)

THE CENSUS (AMENDMENT) RULES, 1970

(Published on the 9th October, 1970)

In the exercise of the powers vested in him by section 2 of the Census Proclamation (Chapter 45), His Excellency the President has been pleased to make the following rules —

Citation

1. These rules may be cited as the Census (Amendment) Rules, 1970.

Amendment of Rule 1 in Government Notice No. 120 of 1963

2. Rule 1 of the Census Rules, 1963 (hereinafter referred to as the principal rules), is amended by the deletion of all words following "apply to" and the substitution therefor of "any census taken in terms of the Proclamation".

Amendment of Rule 2 in Government Notice No. 120 of 1963

3. Rule 2 of the principal rules is amended by the deletion of "Her Majesty's Commissioner" and the substitution therefor of "the President".

Amendment of Rule 3 in Government Notice No. 120 of 1963

4. Rule 3 of the principal rules is amended —

- (a) by the deletion of "the Territory" wherever that phrase occurs and the substitution therefor of "Botswana";
- (b) in paragraph (a) by the deletion of "in Government Notice No. 112 of 1963" and the substitution therefor of "by notice in the Gazette under the provisions of section 1(2) of the Proclamation".

Amendment of Rule 4 in Government Notice No. 120 of 1963

5. Rule 4 of the principal rules is amended —

- (a) in subrule (1) by the insertion immediately before "Schedule" of "First"; and
- (b) by the deletion of subrule (2).

Amendment of Rule 5 in Government Notice No. 120 of 1963

6. Rule 5 of the principal rules is amended in paragraph (a) —

- (a) by the deletion of "the Territory" where that phrase first occurs and the substitution therefor of "Botswana";
- (b) by the deletion of —

"or has been, or is likely to be, absent for more than one year but less than five years; and if such member has been absent for more than one year whether he returns periodically to the Territory;"

and the substitution of —

"or has been absent for more than one year; and shall answer the question what industry he is employed in;"

Insertion of Rule 6A in Government Notice No. 120 of 1963

7. The principal rules are amended by the insertion immediately after rule 6 of the following rule —

“Schedule Prescribed

6A. A schedule in the form of the Second Schedule to these rules is prescribed for the purposes of section 5 and, in so far as it is applicable, for the purposes of sections 6 and 8 of the Proclamation.”.

Amendment of Rule 7 in Government Notice No. 120 of 1963

8. Rule 7 of the principal rules is amended in paragraph (a) by the deletion of “or to undergo any test”.

Amendment of Schedule in Government Notice No. 120 of 1963

9. The schedule to the principal rules is amended —

- (a) by the insertion before “SCHEDULE” of “FIRST”, and the insertion thereunder of “(rule 4)”;
- (b) by the deletion of “Race (whether African, European, Asian, Mixed or other)” and “Literacy (and in what language)”;
- (c) by the addition of —

“Marital status

Details of live births (in the case of women aged fifteen years or more)

Whether parents are alive

Details of agricultural holdings and activity

Industry

Insertion of Second Schedule in Government Notice No. 120 of 1963
