ARRANGEMENT OF PARAGRAPHS

PARAGRAPH

1. Citation

2. Rectification of errors in Act No. 15 of 1988

IN EXERCISE of the powers conferred on the Law Revision Commissioner by section 10 of the Revision of the Laws Act, the following Order is hereby made —

1. This Order may be cited as the Rectification of the Laws (No. 7) Order, 1988. Citation

2. The errors appearing in the Income Tax (Amendment) Act, 1988, are hereby rectified as follows — Rectification of errors in Act No. 15 of 1988

(a) in section 3 thereof which amends section 31 (7) of the Income Tax Act, by the substitution for the full stop and the quotation marks appearing immediately before the proviso to the said section 31(7), a colon;

(b) in section 6 by substituting —

(i) in subsection (1) thereof, for the word “Providing” appearing in the last proviso to the amended paragraph (d) therein, the words “Provided further”,

(ii) in subsection (2) thereof, for the word “employer” appearing in the substituted new paragraph (o) therein, the word “employee”;

(c) in section 9 —

(i) by renumbering paragraphs (i) and (ii) appearing in the amended section 46 (1) therein as paragraphs (a) and (b) respectively, and

(ii) by inserting a comma after the words “individual” and “company” appearing in the said paragraphs (a) and (b) respectively.

(d) in section 10 thereof —

(i) by substituting for the words “The principal Act is amended by the addition of the following new section as section 50 thereof” appearing therein the words “Section 50 of the principal Act is hereby amended by substituting for that section the following new section —”,

(ii) by substituting for the words “Providing that” appearing in proviso (i) to the new section 50 the words “Provided that”,

(iii) by substituting the words “paragraph (XVIII)” appearing in the said proviso (i) to the said section 50, the words, “paragraph (xviii)”, and

(iv) by substituting for the words “section 126 (a) appearing in subsection (2) of the amended section 50, the words “section 126A”;

(e) in section 14 by substituting for the full stop appearing

immediately before the proviso to the amended paragraph 3 of Part VI of the Third Schedule, a colon;

(f) in section 17 thereof —

- (i) by substituting for the full stop appearing at the end of subparagraph (e) of paragraph 2 of the amended Twelfth Schedule, a semicolon and thereafter the word “and”,
- (ii) by deleting the quotation marks appearing immediately before subparagraph (f) of the said paragraph 2,
- (iii) by deleting the comma after the word “bonus” appearing in paragraph 8 of the amended Twelfth Schedule,
- (iv) by deleting the words “or in any of the investments set out in subparagraph (3) hereof” appearing in paragraph 12 (1) of the amended Twelfth Schedule, and
- (v) by deleting subparagraph (3) appearing at the end of paragraph 12 of the amended Twelfth Schedule.
