AMENDMENT OF SCHEDULES (NO. 55) NOTICE, 1992
(Published on 30th October, 1992)

IN EXERCISE of the powers conferred on the Minister of Finance and Development Planning by sections 52 and 53 of the Customs and Excise Duty Act, the Schedules to the Act are amended to the extent set out in the Schedule below.

The provision under subheading No. 1602.49.30 for semicooked rib, frozen, not marinated, in immediate packings of a content of 10 kg or more at a rate of duty of 25% is replaced with a provision for cooked rib, frozen, not marinated, in immediate packings of a content of 10 kg or more at a rate of duty of 15%.

	"0206.22	8	Livers	kg	270u/kg"
NOTE:	The rate of duty on frozen livers of bovine animals is amended from 30% or 350u/kg less 70% to 270u/kg.

NOTE: The subdivisions of subheading No. 2526.10 are deleted and the rates of duty are equalised at 10%.

63.07			By the insertion after sub- heading No. 6307.90.40 of the following:		
	".50	0	Supportive knee-caps, ankle guards and wrist bands, elastic or rubberised	no.	30%"
NOTE: The effect of the amendment is that the provisions for supportive knee-caps, ankle guards and wrist bands, elastic or rubberised, under subheading No. 6117.80.20 at a rate of duty of 60% is deleted with retrospective effect to 1 May 1992 and the provision for the said goods is transferred to subheading No. 6307.90.50 at a rate of duty of 30%.
