Provision is made for a rebate of duty on parts and accessories, for the manufacture of hydraulic presses with a table length of 1 500 mm or more but not exceeding 5 500 mm and of a capacity of 3 000 kN or more but not exceeding 25 000 kN, in such quantities and at such times as the Permanent Secretary, Ministry of Commerce and Industry may allow by specific permit, after proof has been submitted that the presses will be used for the manufacture of body components for motor vehicles.
