| 1. These Regulations may be cited as the Public Service (Amendment) Regulations, 1992. | Citation |
| 2. Regulation 2 of the Public Service Regulations, herein referred to as "the Regulations", is amended by renumbering the present regulation as subsection (1) thereof and by adding the following subsection —
“(2) In these Regulations, where the Permanent Secretary is required to report to, notify or furnish or forward evidence or information to the appointing authority or the responsible officer, as the case may be, and the Permanent Secretary is himself the appointing authority or responsible officer, he shall instead proceed to deal with the matter himself as such appointing authority or responsible officer.”. | Amendment
