SALES TAX (AMENDMENT) (NO. 2) REGULATIONS, 1995
(Published on 13th February, 1995)

IN EXERCISE of the powers conferred by sections 9(1)(a) of the Sales Tax Act, the Vice-President and Minister of Finance and Development Planning hereby makes the following Regulations —

1. These Regulations may be cited as the Sales Tax (Amendment) Regulations, 1995, and shall come, or be deemed to have come, into operation on the 13th February, 1995.

2. The Sales Tax Regulations are amended by substituting for the present First Schedule thereof the following new First Schedule —
