ARRANGEMENT OF PARAGRAPHS

PARAGRAPH

1. Citation and commencement
2. Amendment of Cap. 36:02 (Sub.Leg)

IN EXERCISE of the powers conferred on him by section 3 of the Branding of Cattle Act, the President hereby makes the following Order —

Citation and commencement 1. This Order may be cited as the Zonal Branding Areas and Symbols (Amendment) Order, 1996 and shall come into operation 1st May, 1997.

Amendment of Cap. 36:02 (Sub.Leg) 2. The Zonal Branding Areas and Symbols Order, is amended by inserting, therein, —

Cap. 37:01 (a) the areas defined as the Veterinary Disease Control Zones under the Diseases of Animals Act listed in the first column of the Schedule hereto, which shall be the additional zonal branding areas known by the Veterinary Disease Control Zone Symbols as specified in the corresponding entry in the second column of the Schedule hereto; and

(b) the additional zonal symbols which shall be a combination of the zonal symbol based on Tribal Territories and the Veterinary Disease Control Zone Symbol is specified in the corresponding entry in the third column listed in the Schedule hereto.
