IN EXERCISE of the powers contained in section 23 of the National Registration Act, the Minister of Labour and Home Affairs hereby makes the following Regulations —

1. These Regulations may be cited as the National Registration (Amendment) Regulations, 1998. Citation

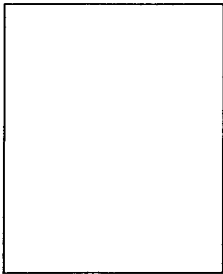

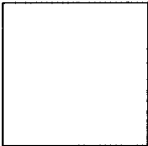
