ARRANGEMENT OF REGULATIONS

REGULATION

1. Citation and Commencement

IN EXERCISE of the powers conferred on the Minister of Works, Transport and Communications by section 128 of the Road Traffic Act, the following regulations are hereby made—

Citation and Commencement **1.** These Regulations may be cited as the Road Traffic (Amendment) Regulations, 2000 and shall come into operation on 1st October, 2000.

Amendment of First Schedule Cap. 69:01 Sub. Leg. **2.** The Road Traffic Regulations (hereinafter referred to as the “the Regulations”) are amended by substituting for the First Schedule thereof a new Schedule as set out in Appendix I below—

Amendment of Regulation 17 **3.** Regulation 17 (1) of the Regulations is amended by substituting for the expression “P1” which appears therein, the expression “P10”
