ARRANGEMENT OF REGULATIONS

REGULATION

IN EXERCISE of the powers conferred on the Minister of Works, Transport and Communications by section 28 of the Road Transport (Permits) Act, the following regulations are hereby made—

1. These Regulations may be cited as the Road Transport (Permits) (Amendment) Regulations, 2000 and shall come into operation on 1st October, 2000.

2. The Road Transport Regulations (hereinafter referred to as “the Regulations”) are amended in the Fourth Schedule by—

- (a) substituting for paragraph 1 thereof the new paragraph 1 set out in Appendix I hereto;
- (b) inserting immediately after paragraph 1 the new paragraph 1A set out in Appendix II hereto;
- (c) substituting for paragraph 4 the new paragraph 4 set out in Appendix III hereto;
- (d) substituting for paragraph 5 the new paragraph 5 set out in Appendix IV hereto;
- (e) inserting immediately after paragraph 5 the new paragraph 5A set out in Appendix V hereto;
- (f) substituting for paragraph 6 thereof the new paragraph 6 set out in Appendix VI hereto;
- (g) substituting for paragraph 7 thereof the new paragraph set out in Appendix VII hereto; and
- (h) substituting for paragraphs 8 and 9 thereof the new paragraphs 8 and 9 set out in Appendix VIII hereto.

3. The Regulations are amended by substituting for regulation 11 thereof the following new regulation—

“11. An application for a permit shall be forwarded directly to the Secretary and shall be accompanied by a fee of P50.00, levied on both Botswana and foreign registered passenger and goods vehicles.”

Amendment of
regulation 14

4. The Regulations are amended by inserting immediately after regulation 14 (c) the following new regulation—

“(d) pay an amount of P200.00, if during the validity of a permit he transfers it to another person.”

Amendment of
regulation 20

5. Regulation 20 (2) is amended—

(a) in paragraph (a) by substituting for the expression “P50” which appears therein the expression “P100.00”; and

(b) in paragraph (b) by substituting for the expression “P100.00” which appears therein the expression “P200.00”.

regulation 27

6. Regulation 27 is amended by—

(a) substituting for the expression “P20” which appears therein the expression “P200.00”; and

(b) substituting for the expression “P100” which appears therein the expression “P400.00”

8. DISCONTINUATION OF PERMIT

If any of the permit fees specified above are paid, and the holder applies for discontinuation of his transport permit before the expiry thereof, or if the Controller should refuse continuation of such transport permit before the expiry of the permit, the sum remitted shall not be refundable.

9. PENALTY FOR LATE RENEWAL

There shall be a penalty for late renewal of all permits at the rate of P 10.0 every day that lapses after the fifth day of expiry, for a period of three months. Beyond a period of three months, the permit shall be recommended for either suspension for a given period or revocation.
