ARRANGEMENT OF REGULATIONS

REGULATION

1. Citation
2. Insertion of paragraphs 2.A, 3.A and 4.A to Fourth Schedule to Cap 69:03 Sub. Leg.
3. Substitution of paragraph 10 of Fourth Schedule to the Regulations

IN EXERCISE of the powers conferred on the Minister of Works, Transport and Communications by section 28 of the Road Transport (Permits) Act, the following Regulations are hereby made —

1. These Regulations may be cited as the Road Transport (Permits) (Amendment) Regulations, 2000, and shall come into operation on the 1st March, 2000. Citation and commencement
2. The Road Transport (Permits) Regulations (hereinafter referred to as “the Regulations”) are amended in the Fourth Schedule by the insertion — Insertion of paragraphs 2.A, 3.A and 4.A to Fourth Schedule of Cap. 69:03 Sub. Leg.
 - (a) immediately after paragraph 2 thereof, of the new paragraph 2.A set out in Appendix I of the Schedule hereto;
 - (b) immediately after paragraph 3 thereof, of the new paragraph 3.A set out in Appendix II of the Schedule hereto; and
 - (c) immediately after paragraph 4 thereof, of the new paragraph 4.A set out in Appendix III of the Schedule hereto.
3. The Regulations are amended in the Fourth Schedule by substituting for paragraph 10 thereof, the new paragraphs 10 (a) and 10 (b) set out in Appendix IV of the Schedule hereto. Substitution of paragraph 10 of Fourth Schedule to the Regulations
