DECLARATION OF TOWNSHIPS (AMENDMENT) ORDER, 2001
(Published on 15th June, 2001)

IN EXERCISE of the powers conferred by section 2 of the Townships Act, the Minister of Local Government hereby makes the following Order —

1. This Order may be cited as the Declaration of Townships (Amendment) Order, 2001. Citation

2. The Schedule to the Declaration of Townships Order is amended by substituting, for the description of the boundaries of Lobatse Township in item 6 thereof, the following new description — Amendment of Declaration of Townships Order Cap.

“6. LOBATSE TOWNSHIP

(Sub.Leg)

The boundary of the Township is as follows:

Commencing at the northwest beacon of Lot 1, Lobatse, the boundary runs generally southeastwards along the northern boundary of the said Lot 1, Lobatse, to the northeastern beacon thereof, being a beacon on the western boundary of the Railway Reserve No 7 - JO; thence southeastwards in a straight line to a beacon lettered “A” on diagram DSL 341/91 being a beacon defining the northwestern corner of Portion 20 (a portion of portion 2) of the Farm Woodhall 11-JO; thence in a direction generally southeast in a straight line to a beacon lettered “C” on the diagram No A4066/1926 being a beacon on the eastern boundary of portion 3 (Christina) of the farm Woodhall 11-JO; thence northwestwards along the western boundary of the Remaining Extent of the Lobatse Block, (Farm Woodlands 8-JO) to a beacon lettered “J” on the diagram A3253/1927 being a beacon on the eastern boundary of the Railway Reserve No 7-JO; thence northwards along the eastern boundary of the said Railway Reserve No 7-JO to a beacon lettered “A” defining the northwestern beacon of Farm Woodlands 8-JO; thence southeastwards in a straight line along the northern boundary of the said farm boundary to a beacon lettered “A” on diagram DSM 1011/2000 being the northwest beacon of Portion 46 of the Remaining Extent of the Lobatse Block; thence southwestwards and southeastwards along the western and southern boundary of the said Portion 46 of the Remaining Extent of the Lobatse Block to a beacon lettered “C” being a beacon on the International Boundary of Botswana and the Republic of South Africa; thence in a straight line southwestwards along the said international boundary to a beacon lettered “B” on diagram 2168/53 being a beacon defining the northeast corner of Farm Traverston 10-JO; thence in a straight line southwestwards along the northern boundary of the said Farm 10-JO to a beacon lettered “A” being the northwest corner also on the eastern boundary of Lot 4901 Lobatse; thence in a southeasterly direction along the eastern boundary of the said Lot 4901, to a beacon lettered “L” on diagram DSL 84/91; thence in a northwesterly direction to beacon “M” of the said Lot 4901, Lobatse, being also a beacon on the eastern boundary of Lot 1735, Lobatse; thence generally southwestwards and northwestwards along the southern and southwestern boundaries of the said Lot 1735, Lobatse to the beacon common to the said Lot 1735, Lobatse, the Remainder of the Farm Springfield 18-JO and Lot 333 Lobatse; thence generally southwards along the eastern boundaries of Lots 333, 620 and 330 Lobatse, the southeastern boundaries of Lots 330, 620 and 329 Lobatse, and the southwestern boundary of Lot 329,

Lobatse to the westernmost beacon of the said Lot 329 Lobatse, being a beacon on the eastern boundary of the Railway Reserve No7-JO; thence in a straight line to the southernmost beacon of Lot 322, Lobatse, being a beacon on the western boundary of the Railway Reserve No 7-JO lettered "C" on the diagram 7459/59 of the Farm 15-JO; thence generally southwestwards along the western boundary of the Railway Reserve 7-JO also the eastern boundary of Farm 15-JO to beacon lettered "L"; thence generally northwestward, northeast, northwest, southeast, northwest to the beacon "A" being the northwest beacon of the said Farm 15-JO; thence northeastwards in a straight line to beacon "R" on diagram 482/59 being the beacon of the intersections of lot 322 Lobatse and Farms Geluk 14-JO and Nooitgedacht 13-JO; thence generally northwards along the western boundaries of the said Lot 322 Lobatse, the southern, western and northern boundaries of Lot 321 Lobatse and the western boundary of Lot 164 Lobatse to the beacon where the latter boundary intersects the southern boundary of Lot 1 Lobatse; thence generally westwards and northwards along the southern and western boundaries of the said Lot 1 Lobatse, to the point of commencement, as will more fully appear on Plan NO JO-109c deposited with the Director of Surveys and Mapping Gaborone."
