ARRANGEMENT OF REGULATIONS

REGULATION

IN EXERCISE of the powers conferred on the Minister of Lands and Housing by section 37 of the Tribal Land Act, the following Regulations are hereby made —

1. These Regulations may be cited as the Tribal Land (Amendment) Regulations, 2011.

Citation

2. The Tribal Land Regulations (hereinafter referred to as the Regulations) are amended in regulation 2 —

(a) by substituting for subregulation (1) the following new subregulation —
“Procedure for appointment of members of land board 2 (1) The Ministry of Lands and Housing shall invite members of the public residing in a tribal territory, to apply to the secretary of a land board for appointment as members of the land board as specified in the third column of the First Schedule to the Act.

(2) The invitation in terms of subregulation (1) shall be —

(a) made at least two months before appointment to any land board.; and

(b) published in two or more newspapers of national circulation.”;

(b) subregulation (2) by —

(i) deleting the words “election and” appearing on the first line of the paragraph, and

(ii) substituting for the word “election” where it appears in paragraph (d) the word “appointment.”;

(c) by substituting for subregulation (3A) the following new subregulation —
“(3A) The Land Board Selection Committee shall, from among the persons interviewed in terms of subregulation (3), shortlist 15 candidates and refer them to the Minister for appointment.”;

(d) by deleting subregulation (4);

(e) by deleting subregulation (5);

(f) by deleting subregulation (6);

(g) by deleting subregulation (7);

(h) in subregulation (9) by substituting for the word “elected” the word —

(i) “shortlisted” where the word appears on the first line of the paragraph, and

(ii) “appointed” where it appears in paragraph (b).”.

3. The Regulations are amended in regulation 3 —

- (a) by substituting for subregulation (1) the following new subregulation —
“(1) The Minister shall, at intervals of approximately 12 months, appoint a chairperson of the board and a deputy chairperson who shall act as chairperson of any meeting at which the chairman is absent.”; and
- (b) by substituting, in subregulation (2), for the word “election” appearing on the second line of the paragraph the word “appointment”.
